**AMENDMENT TO DECLARATION
OF COVENANTS AND RESTRICTIONS**

This Amendment to Declaration of Covenants and Restrictions made and entered into this 21st day of December, 1998, by the Woods at Crooked Mile Homeowners Association, Inc. a Florida non profit corporation ("Association").

WHEREAS, the members of the association voted to amend the Covenants and Restrictions of the Association at a regular or special meeting of the members of the association.

WHEREAS, the subject of the amendment approved by the members is set forth in this instrument.

NOW, THEREFORE, in consideration of the premises, it is agreed as follows:

1. AMENDMENT TO PARAGRAPH 10, SUBPARAGRAPH (k). Nuisances, Waste and Miscellaneous Provisions, shall be amended to read as follows:

(K) Wheeled vehicles of any kind or any other offensive objects may not be parked or kept on any part of a lot, except that private automobiles and private pick-up trucks without commercial signs may be parked in the driveway. Visitors for periods of less than twelve hours are excluded. Boats, recreational vehicles, utility trailers, mobile homes, camping trailers and all commercial vehicles must be completely housed within the closed garage.

2. The remaining portions of the Declaration of Covenants and Restrictions shall continue in full force and effect.
