## AMENDMENT TO BYLAWS OF THE WOODS AT CROOKED MILE HOMEOWNERS' ASSOCIATION, INC.

NOW, THEREFORE, in consideration of the premises, it is agreed as follows:

- 1. Amendment to Article V, Section 6. Limitation. Section 6 of Article V of the Bylaws is amended to read as follows: Without the approval of Owners holding at least 75% of the votes of the Association, the Board shall not approve any capital expenditures in excess of two thousand dollars (\$2,000) other than rebuilding, repairing or replacing damaged property or as specifically provided in the Declaration.
  - 2. The remaining portions of the Bylaws will remain in full force and effect.
