OF COVENANTS AND RESTRICTIONS

Any committee member may be removed, with or without cause, by the Developer, and after Turn Over, by the Association. In the event a vacancy in office of a committee member occurs for any reason, the Developer, and after Turn Over, the Association, may appoint a successor who shall serve as such for the remaining term of office. None of the members shall be entitled to any compensation for service rendered pursuant to this Declaration. The Committee may designate a representative to act for it, which representative need not be a member of the Committee or a Lot owner and may be
